## Rules and Regulations

The following constitutes part of the Agreement between the Georgia Funeral Service EXPO2010 and the Exhibitor. Signing this Agreement indicates acceptance & agreement to comply with terms & conditions herein.

- The Georgia Funeral Service EXPO2010 will be held at the Georgia Railroad Freight Depot, 65 Martin Luther King Jr. Drive, Atlanta, GA 30334 on March 1-2, 2010.
- Exhibit Set-Up will be on Sunday, February 28 and Monday, March 1, 2010, beginning at 8 am. Vehicle exhibitors will be allowed to enter the Exhibit Hall through the Dock first. All exhibit set-up should be completed no later than 11 am on March 1. Move-out must be completed by 10 pm, Tuesday, March 2. **The Vendor coordinator will call all vendors directly for move-in, shipments of materials and related.**
- **Exhibit Schedule:**
  - Monday, March 1, 2010: Noon to 4 pm, reception in Exhibit Hall 4-6 pm. (Vendors will eat early, 11:30 am)
  - Tuesday, March 2, 2010: 12:30 to 4:00 pm. (Vendors will eat early, 11:30.)
  - Georgia General Assembly will be invited to attend & view the Exhibit Hall anytime during exhibit hours Tuesday
  - Lunch: served for Non-vendors in the Exhibit Hall Noon-1:30 on Monday, March 1 and Tuesday, March 2, 2010.
  - Admission to the Exhibit Hall is by convention badge ONLY, including all Exhibitors.
  - Exhibitors will be allowed admission to their booths one hour before exhibit opening. All other individuals will be admitted only during the specified exhibit hours and only with proper convention badges.
- **Release of Liability:** The Exhibitor hereby permanently releases and holds harmless Georgia Funeral Directors Association, Georgia Funeral Service Practitioners Association and the Independent Funeral Directors of Georgia, its members, agents and/or employees, for loss, theft, damage or destruction of exhibit items, from any injury to himself or employees or agents while in the Exhibit Hall, from any damage of any nature or character including any damage to his business by reason of failure to provide space for the exhibit or removal of exhibit, or any action of any nature or kind, including from the failure to hold the EXPO as scheduled.
- No Exhibitor may allow any article to be brought into nor allow any act on the premises which will increase the premium on the insurance policies held by the owner of the building nor the event insurance held by the Expo management, nor permit anything to be done by employees or agents by which the premises shall in any manner be marred or defaced. Any damage done shall be made good in full with the owners of the building or with GFDA/GFSPA/IFDG, as their interest may appear.
- No signs or other articles shall be affixed, nailed or otherwise attached to walls, doors or other surfaces of the property such as to deface, alter or destroy the same. No attachments will be made to the floors by screws, nails or any other device that would damage or mar them. All exhibit space is leased subject to these restrictions.
- Exhibitors shall not be permitted to solicit business in booths other than their own or in the aisles.
- EXPO2010 management reserves the right to restrict exhibits that, because of noise or any other reason, become objectionable, and to prohibit or remove any exhibit that, in the opinion of EXPO2010 management, may detract from the general character of the Expo. This includes persons, things, conduct, printed material, and/or anything of a character that may be objectionable to the Expo as a whole or that may be in violation of any federal or state or municipal law or ordinance.
- The Exhibitor agrees to comply with all Americans with Disabilities Act requirements in the design of booths.
- **Legislative Reception Schedule:** The 4th Annual Georgia Funeral Service Legislative Reception takes place 5:30 to 7:30 pm, March 2, 2010, Blue Room of the Georgia Railroad Freight Depot. This is a separately ticketed event; exhibitors wishing to attend should complete a separate sign-up sheet. Admission to the Blue Room requires a separate ticket.
